**PASSENGERS AGREEMENT FOR LIMOUSINE SERVICE DATED: \_\_\_\_\_**

The consumption of any alcoholic beverages is unlawful, when consumed by a minor. There will be no alcoholic beverages transported in the passenger compartment of the vehicle. Also, no alcoholic beverages will be carried in the trunk, or any other locked compartment of the vehicle. This rule shall apply to any and all other illegal substances. If at any time, any of the passengers are found to have in their possession or have been at any time during the course of the service consuming any alcohol or other illegal substance, the service shall be terminated. All money shall be forfeited, and a parent shall be notified. Chauffeur has the option of returning to the point of pickup or ending service at point of infraction. Chauffeur shall also have the right to examine all bags or parcels to be placed in vehicle to determine if they contain any illegal substances. Due to the high risk insurance factor, the Moonroof and divider windows will not be operational.
